### 3. HAZARDS IDENTIFICATION OF THE PREPARATION

Flammable.

Irritating to skin.

Toxic to aquatic organisms, many cause long-term adverse effects in aquatic environment.

Harmful; may cause lung damage if swallowed.

#### \*\*Bitumen

Not expected to be a health hazard at ambient temperature. Hydrogen sulphide (H<sub>2</sub>S), an extremely flammable and toxic gas and other hazardous vapours may evolve and collect in the headspace of storage tanks, transport vessels and other enclosed containers. Hydrogen sulphide is highly toxic and maybe fatal if inhaled. May dull the sense of smell, so do not rely on odour as an indication of hazard. Contact with hot material can cause thermal burns may result in permanent skin damage. Hot product may cause severe eye burns and/or blindness.

### 4. FIRST AID MEASURES

#### General

In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

#### Inhalation

Remove to fresh air, keep patient warm and at rest, if breathing is irregular or stopped, administer artificial respiration. Give nothing by mouth. If unconscious place in recovery position and seek medical advice.

### 5. FIRE-FIGHTING MEASURES

Extinguishing media

Recommended Alcohol resistant foam, CO2, Powders, Water spray

Not to be used Waterjet

Recommendations Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Appropriate breathing apparatus may be required. Cool closed containers exposed to fire with water. Do not allow run-off from fire fighting to enter drains or water courses.

### 6. ACCIDENTAL RELEASE MEASURES

Exclude sources of ignition and ventilate the area. Avoid breathing vapors. Refer to protective measures listed in sections 7 and 8. Contain and collect spillage with non-combustible adsorbent materials, e.g. sand, earth, vermiculite, diatomaceous earth and place in container for disposal according to local regulations ( see section 13 ). Do not allow to enter drains or watercourses. Clean preferably with a detergent; avoid use of solvents. If the product contaminates lakes, rivers or sewages, inform appropriate authorities in accordance with local regulations.

### 7. HANDLING AND STORAGE

Handling Vapors are heavier than air and may spread along floors. Vapor may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapor in air and avoid vapor concentration higher than the occupational exposure limits. Additionally, the product should only be used in areas from which all naked lights and others sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard.

Preparation may charge electrostatically Always use earthing leads when transferring from one container to another. Operators should wear anti-static footwear, and floors should be of the conducting type.

Container Storage Keep container tightly closed. Isolate from sources of heat, sparks and open flame.

No sparking tools should be used.

Always keep in containers of same material as the original one.

Never use pressure to empty : Container is not a pressure vessel.

Skin Contacted Avoid skin and eye contact. Avoid inhalation of vapor and spray mist.

Application areas Smoking, eating and drinking should be prohibited in application areas.

For personal protection see section 8.

Comply with the health and safety at work laws.

When operators ,Whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapor in all cases. In such circumstances they should wear a compressed aired respirator during the spraying process until such time as the particulates and solvent vapor concentration has fallen below the exposure limits.

Storage

Store in accordance with local rules and legislation. Observe label precautions .

Store between 5 and 30 °C in a dry, well ventilated place away from sources of heat and direct sunlight. Keep away from sources of ignition .Keep away from oxidizing agents, from strongly alkaline and strongly acid materials. No smoking . Prevent unauthorized access. Containers which are opened must be carefully resealed and kept upright to prevent leakage.
